## What is the Restoration Center?

The Dickinson Center, Inc. Restoration Center is a 24/7 long-term structured residential (LTSR) facility that promotes healing and recovery.

The following individualized services are provided by highly-trained mental health and medical treatment professionals:

- Individual, group, and family therapy (when appropriate)
- Psycho-education (understanding of signs, symptoms, medications, and ways to cope with disorders)
- Psychiatric care for stabilization and medication management
- Service coordination for admission, ongoing home community connection, and discharge planning resources/connections
- Skills training for personal, home, community, occupational, and social settings
- Physical healthcare coordination by our nursing staff
- Competency restoration & more

## Who does this serve?

The facility is designed to serve up to 16 forensically involved adult males.

## How does the LTSR help?

As the individuals transition from the Restoration Center, staff will provide a continuum of care to assist with referrals for support services in the community such as Blended Case Management, Psychiatric Rehabilitation, Peer Support, Mobile Medication Management, and more.

The residents' outcomes and goals of the program are to:

- Restore competency
- Stabilize psychiatric conditions
- Divert from inpatient and/or further incarceration due to mental health issues
- Empower to live independently
- Establish support network of services and natural supports prior to and following discharge from the facility

## Where is the LTSR located?

We are located at 200 Service Center Road, Brookville, PA, off the Hazen exit 81 on I-80 (near the Jefferson County Jail).

The facility includes:

- 16 single bedrooms
- Shared restrooms
- All anti-ligature fixtures for safety
- Restraint free settings
- Locked and secure environment
- Comfortable dining & common areas

## What is the admission criteria?

- Adult male (18 or older)
- Severe mental illness
- Severe psychosocial disability
- Non-violent offenders
- Can receive adequate care in the facility and does not need acute hospitalization
- Voluntary or involuntary civil commitment
- Ordered to facility for treatment over incarceration
- Ordered for mental health treatment for competency restoration
