





## A Safe Haven for Vulnerable Individuals

Since the early 1970s, BEACON LIGHT ADULT RESIDENTIAL SERVICES (BLARS) has been a cornerstone for individuals facing intellectual and developmental disabilities or mental health diagnoses. The organization is renowned for its commitment to providing a nurturing and safe environment where each person can thrive.

#### **Comprehensive Residential Programs**

BLARS has established a variety of residentially oriented programs that cater specifically to the unique needs of its clients. These include Intermediate Care Facilities (ICFs), Adult Day Services, Community Waiver Programs, Community Residential Rehabilitation Services (CRRS), and the Community Stabilization and Reintegration Unit (CSRU) located in McClure, PA. Each program is designed to foster an environment where individuals can benefit from "active treatment," focusing on developing daily living and coping skills in the least restrictive settings possible. This approach not only promotes independence but also cultivates a sense of belonging and community among residents.

#### **Celebrating Recent Successes**

Over the past year, BLARS has achieved remarkable milestones, particularly within the Community Stabilization and Reintegration Unit (CSRU). This unit successfully discharged 27 individuals, with 89% of these discharges deemed appropriate as the individuals met their treatment objectives and transitioned back into preferred living arrangements. Additionally, the organization has maintained a high census and stable staffing levels, indicating a robust operational structure ready to support its residents effectively.

#### **Comforting Care**

Despite the successes, BLARS faces challenges, especially regarding the aging population and its increasing medical complexities. Several residents encountered significant medical issues leading to hospitalizations; however, proactive communication and careful planning with healthcare providers have ensured that most individuals could return to a familiar and comforting home setting after treatment. This focus on collaborative care exemplifies BLARS's dedication to holistic individual wellness.

#### **Strategic Growth and Future Vision**

In collaboration with Strategic Consulting Partners, BLARS is embarking on a transformative journey with a newly developed strategic plan set to cover 2025 to 2027. During this process, staff members engaged in meaningful discussions resulting in the approval of new strategic objectives by the Board of Directors in April 2025. Alongside these objectives, the following revised mission statement was crafted: "BLARS provides residential services to vulnerable individuals in safe, respectful, and healing environments."

Furthermore, BLARS's waiver programs recently attained the prestigious designation of "Primary Provider" under the Performance Based Contracting system established by the Office of Developmental Programs (ODP). This accomplishment is a testament to BLARS's commitment to accountability and excellence, tying meaningful incentives to performance and ensuring high-quality service delivery for its clients.

## BLARS will Continue to Make a Significant Impact

BLARS remains a beacon of hope for adults with intellectual and developmental disabilities and mental health diagnoses through its comprehensive programs, successful initiatives, and strategic growth plans. As the organization navigates future challenges and opportunities, its commitment to fostering a safe, respectful, and healing environment will undoubtedly remain at the forefront of its mission.

Notably, the redesign of the Rights and Ethics Committee has increased involvement from consumer and family advocates, fostering a more inclusive approach to decision-making. Furthermore, the continued funding from the Warren County School District for the Elementary Student Assistance Program (SAP) showcases the agency's dedication to supporting youth in their educational journeys.

#### **Innovative Programs and Services**

Innovation is key in the field of mental health, and BLBHS has embraced this by launching several new programs and initiatives. The introduction of a Transcranial Magnetic Stimulation (TMS) program at the Warren Outpatient Clinic represents a significant advancement in treatment options. Since its launch in October 2025, eleven individuals have successfully completed TMS treatment, with five currently enrolled and additional referrals pending.

In Bradford, BLBHS launched a satellite outpatient clinic and established a psychiatric rehabilitation program to increase services in the community. These initiatives are vital for increasing accessibility to mental health services and ensuring that individuals can receive care closer to home.

#### Investing in Staff Development for a Sustainable Future

The success of any organization lies in the strength and dedication of its workforce. Recognizing this, BLBHS prioritizes the ongoing professional development of its staff. Fostering a culture of growth and learning not only enhances service delivery but also solidifies the foundation for long-term stability in the mental health care sector.

In line with this commitment, BLBHS has set forth ambitious goals for the future. Plans include the expansion of psychiatric rehabilitation programs to encompass youth ages 14-17 and the broadening of adult community service lines into McKean County. Additionally, the plans aim to implement strategic initiatives that enhance operational efficiency and continue advocating for critical regulations impacting behavioral health funding.

### **Looking Ahead: A Vision for Continued Growth**

As BLBHS charts its course for the future, it remains steadfast in its mission to provide exemplary behavioral health care. The agency's proactive approach to advocacy, innovation, and workforce development positions it as a leader in the field. ## Navigating Change & Embracing Opportunities

The landscape of mental health and substance use services is undergoing significant transformation. With mounting challenges contrasted by new opportunities, organizations like DEERFIELD BEHAVIORAL HEALTH (DBH) are at the forefront of this evolution, striving to enhance care delivery and accessibility.

## **Connecting Mental Health and Substance Use Disorders**

A considerable number of individuals face the dual challenge of mental health disorders alongside substance use disorders. Research indicates that adults grappling with mental illness, such as depression or anxiety, are markedly more likely to engage in illicit drug use than those without such conditions. This intersection is critical, as it underscores the necessity for integrated treatment approaches. By recognizing and addressing the intertwined nature of these issues, DBH aims to provide a holistic care model that fosters lasting recovery.

This year, the alarming trend of opioid-related overdoses continues to dominate discussions in mental health circles, particularly with substances like fentanyl being mixed with other drugs unbeknownst to users. DBH and their Deerfield Centers for Addictions Treatment (DCAT), have been serving those struggling with substance abuse since 1993, providing essential services such as assessments, therapy, and medication-assisted treatment. Harm reduction strategies emphasizing increased access to naloxone and educational resources are also crucial in curbing overdoses and improving the safety of vulnerable populations.

#### **Enhancing Access and Equity in Care**

Many individuals encounter financial and insurance hurdles, compounded by a shortage of qualified mental health professionals. DBH is dedicated to dismantling these barriers, focusing particularly on underserved regions and rural communities. By advocating for equitable access to integrated care, DBH seeks to ensure that every individual receives the support he or she needs, irrespective of background.

#### **Services Tailored to Community Needs**

At DBH, its mission revolves around delivering comprehensive, accessible, and compassionate psychiatric care. It prides itself on offering a unique blend of diagnostic, therapeutic, and contract behavioral health services with multiple offices across western and central Pennsylvania.

In the past year, DBH successfully expanded its team, recruiting additional psychiatrists, certified mental health nurse practitioners, and certified physician assistants. This growth not only increases patient capacity but also enriches the quality of care delivered, solidifying DBH's role as a critical resource for individuals in need within the communities it serves.

## Looking Forward: A Commitment to Excellence and Recovery

Deerfield Behavioral Health is excited about the future and is committed to promoting long-term wellness, recovery, and dignity for each person it serves. By continuing to strengthen partnerships with public and private organizations across 23 counties in northwestern and central Pennsylvania, DBH aims to build a robust provider practice that supports mental health and substance use recovery.

# Celebrating Progress

The past year for DICKINSON CENTER, INC. (DCI) has been one of remarkable achievements and steadfast commitment to enhancing behavioral health services in the community. At the heart of this transformation is the construction and completion of the new centralized office location in St. Marys.

#### The Journey to a New Office Space

The quest for a more suitable office space for DCl's St. Marys programs has spanned nearly a decade. Initially, DCl sought an existing building that could accommodate its needs. However, after extensive searching and considering multiple properties, it became evident that the ideal structure—one that met both size and budgetary requirements—simply did not exist.

Faced with this reality, DCI made the strategic decision to construct a new facility. The objective was to find a location that would be accessible to consumers. The team successfully selected a site at the corner of Railroad and Market Streets.

#### **Overcoming Challenges**

No journey is without its obstacles, and the construction phase was undeniably affected by the global pandemic and rising costs. Yet, in the field of behavioral health, adaptability is key. DCI embraced these challenges headon, demonstrating resilience throughout the process. By June 2025, staff from various programs—including Parents as Teachers, the Children's Center, school-based staff, and the Crossroads program—moved into the new space, followed by the Outpatient Services, on July 11, 2025.

This modern facility consolidates what were once three separate rental locations, providing a cohesive environment designed to meet the specific needs of the programs and, most importantly, the consumers it serves.

## Strategic Growth: Looking Ahead with Optimism

Beyond the new office location, DCI has also embarked on updating its strategic plan in collaboration with other affiliates within the Journey Health System. This comprehensive plan outlines key areas of focus over the next three years, including enhancing and expanding service offerings, strengthening financial sustainability through continual evaluation of service lines, and exploring new funding opportunities.

Moreover, DCI aims to cultivate a culture of engagement, collaboration, and innovation among its staff and the wider community. Despite the uncertainties surrounding funding streams and the broader challenges faced within the industry, there is a strong sense of optimism about the organization's future. The leadership teams and staff at both DCI and Journey Health are dedicated and committed; fostering confidence in the path forward.

#### A Vivid Future Ahead

As DCI continues its journey, the successful completion of the new St. Marys office—and the invaluable support from the community which helped raise \$1.5 million, exceeding the original goal of \$1 million—has set a solid foundation for future endeavors. With a renewed vision and a robust strategic plan, DCI is poised for growth and is fully equipped to enhance the lives of those it serves. This year has proven that with determination, support, and a clear direction, transformation is not only possible but thriving.

## Supporting Independence

#### The FOREST/WARREN MENTAL WELLNESS ASSOCIATION

(FWMWA), nestled in the heart of Warren, Pennsylvania, has had another productive year dedicated to enhancing the lives of mentally challenged individuals in the community. As a consumer-run organization integrated within the Journey Health System, FWMWA focuses on empowering its members by providing essential life skills and support to help them thrive independently.

#### A Hub of Connection and Learning: The Friendship House/Drop-In Center

At the core of FWMWA's mission is the Friendship House/Drop-In Center, a welcoming space open to everyone from Monday to Friday, 8:30 a.m. to 4:30 p.m. This vibrant hub encourages social interaction and personal growth, where individuals from the Warren State Hospital and the broader community gather to forge friendships, learn new skills, and engage in various activities. With amenities like a snack bar, beverage counter, pool table, dart board, and foosball table, the center is designed to cater to diverse interests and needs.

Special events, such as karaoke and BINGO every Friday from 1:00 to 2:00 p.m., create an atmosphere of fun and camaraderie that keeps participants returning for more. Additionally, the cooking class held on Wednesdays from 11:00 a.m. to noon is a fantastic opportunity for community members to learn valuable kitchen skills while enjoying each other's company.

#### **Addressing Social Determinants of Health**

FWMWA extends its impact through the Community Based Care Management program, which addresses critical Social Determinants of Health within Warren and Forest counties. By focusing on pressing issues such as homelessness, housing, and transportation, FWMWA provides a lifeline to individuals in need. Services include rental assistance, utility vouchers, clothing, and food support, ensuring that community members have access to essential resources for a healthier, more stable lifestyle.

#### **Empowerment through Fairweather Lodges**

Another vital component of FWMWA's offerings is the Fairweather Lodges—one for women and one for men. These shared housing and vocational programs are rooted in the principles of self-governance and interdependence. Participants share equal responsibility in managing household tasks, establishing policies, and overseeing financial matters, thereby fostering a sense of community and collaboration. The Fairweather Lodges provide a supportive environment where members can pursue their aspirations of independent living and employment.

#### A New Focus on Vocational Training

Despite the successes, FWMWA has faced challenges, particularly with the recent closure of the WellSpring business, which had provided cleaning and landscaping services. This shift has necessitated a refocus toward vocational education and training for participants. The program's Vocational Coordinator is committed to guiding individuals in securing employment opportunities through collaborations with PA CareerLink® and local temp agencies, ensuring that those they serve continue to progress toward meaningful work.

#### **Building Brighter Futures Together**

As FWMWA continues its vital work, the unwavering commitment to supporting mentally challenged individuals is evident. Together, with compassion and dedication, they are building brighter futures for all.

# A Pillar of Mental Healthcare in Erie



Since its establishment in 1961, STAIRWAYS BEHAVIORAL HEALTH (SBH) has dedicated itself to providing compassionate mental healthcare to the Erie community. With a mission centered on innovation and collaborative partnerships, SBH has firmly established itself as one of the largest mental healthcare agencies in the region. As community needs evolve, so too does SBH's commitment to delivering quality services that support mental health and substance use recovery.

### **Innovative Programs Tailored to Community Needs**

In the past year, SBH has made significant strides in enhancing its service offerings. Notably, the expansion of the Outpatient Drug and Alcohol Program has played a crucial role in addressing substance use issues prevalent in the community. Furthermore, the introduction of Medication-Assisted Treatment, including Brixadi®, marks a progressive step towards incorporating cutting-edge practices into treatment plans. This initiative reflects SBH's dedication to evidence-based approaches that provide clients with effective tools for recovery.

Additionally, recognizing the growing demand for psychosocial rehabilitation, SBH has bolstered its Psychiatric Rehabilitation Program by introducing new therapeutic groups, which meet twice weekly. Feedback from participants has been overwhelmingly positive, underscoring the importance of group-based treatments in enhancing mental well-being.

### **Collaborative Partnerships for a Brighter Future**

Collaboration is at the heart of SBH's approach.
Throughout the year, SBH has strengthened partnerships with organizations such as the Erie County Office of Mental Health and Intellectual Disabilities, the Mental Health Association, NAMI of Erie County PA, and Erie County Office of Drug and Alcohol Abuse. Additionally, the SBH Assertive Community Treatment (ACT) was asked to join an Erie Together cohort aimed at identifying staff recruitment and retention strategies for their program. These alliances foster a unified front in tackling mental health challenges and enhancing community resilience.

#### **Community Recognition and Engagement**

The impact of SBH's tireless efforts has not gone unnoticed. In October 2024, the Mayor's Office of Erie honored SBH with a proclamation recognizing its long-standing commitment to serving Erie County residents. Such accolades reflect the trust and appreciation the community has for SBH's work. This sentiment was further echoed during the August 2024 Erie Gives campaign, when SBH celebrated its second-highest year of contributions, showcasing strong public engagement and support.

To ensure that more people are aware of its offerings, SBH has undertaken strategic marketing initiatives. Through radio broadcasts in collaboration with local stations and eye-catching billboards displayed throughout Erie. These efforts are part of a broader campaign to increase visibility and accessibility of care.

#### **Engagement beyond Mental Health Services**

SBH also believes in giving back to the community beyond its clinical services. As part of the Adopt-a-Highway program, SBH sponsors a 1.5-mile section of East 38th Street, demonstrating its commitment to environmental stewardship. Additionally, partnerships with local sports teams like the Erie Otters allow SBH to engage with the community in fun and meaningful ways.

#### A Commitment to Continuing Care

As SBH moves forward, its unwavering commitment to providing comprehensive mental healthcare remains steadfast by providing hope and support for those navigating their mental health journeys in Erie County.


